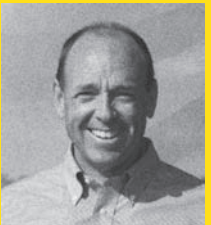

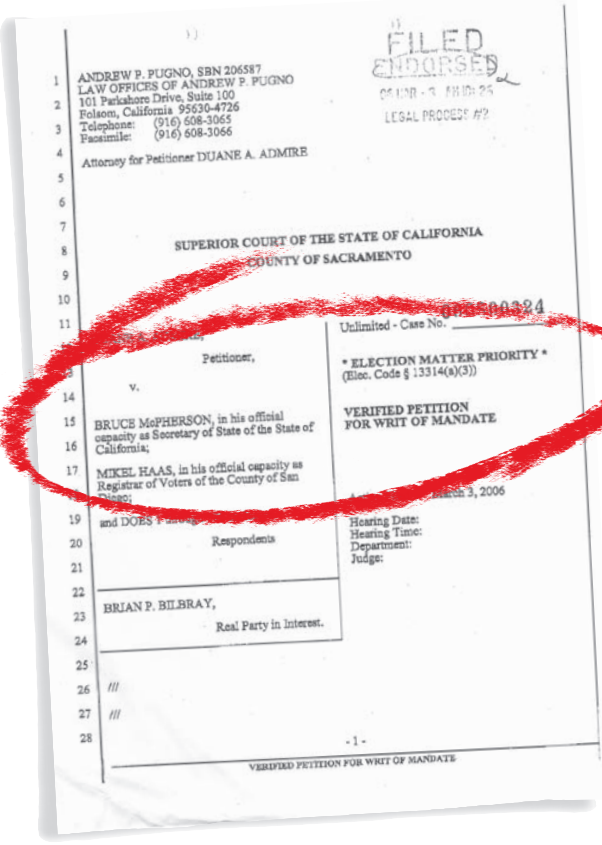


ROACH FAKED A NEWSPAPER ENDORSEMENT

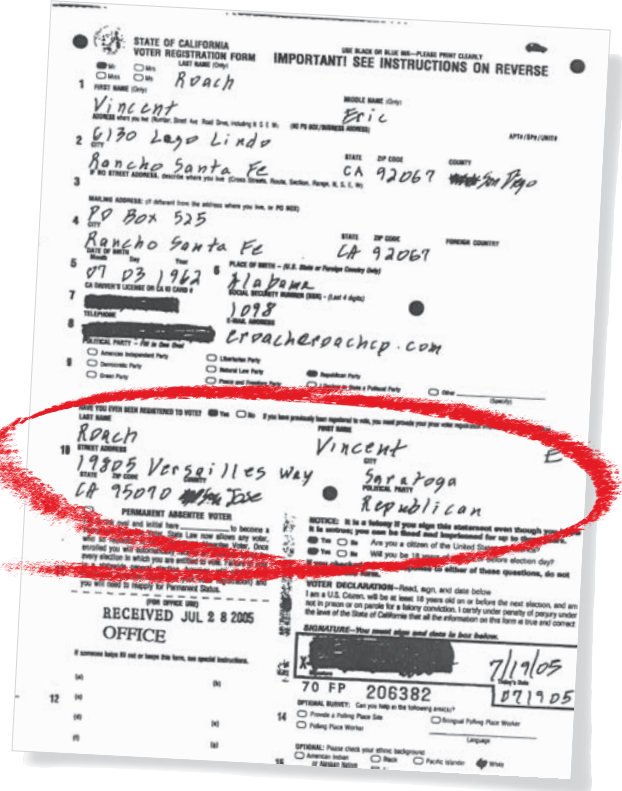
It cost taxpayers thousands of dollars to defend against Roach's frivolous lawsuit.



ROACH IS A SAN FRANCISCO TRANSPLANT

It's no wonder most local citizens had never heard of V. Eric Roach until he started his barrage of campaign ads. He calls himself a "Rancho Santa Fe businessman" but his company is in Utah. (Source: Altiris Corporate Records)

When he registered to vote in our district nine months ago, Roach signed a statement claiming to be previously registered in the county of "San Jose." No such county exists in California, but the city of San Jose is in Santa Clara County in the San Francisco Bay Area. ROACH IS TRYING TO BUY HIS SEAT IN CONGRESS

Former Congressman Duke Cunningham made \$2.4 Million in bribes while in Congress.

V. Eric Roach has spent more than \$2.4 Million trying to buy Cunningham's seat for himself.
