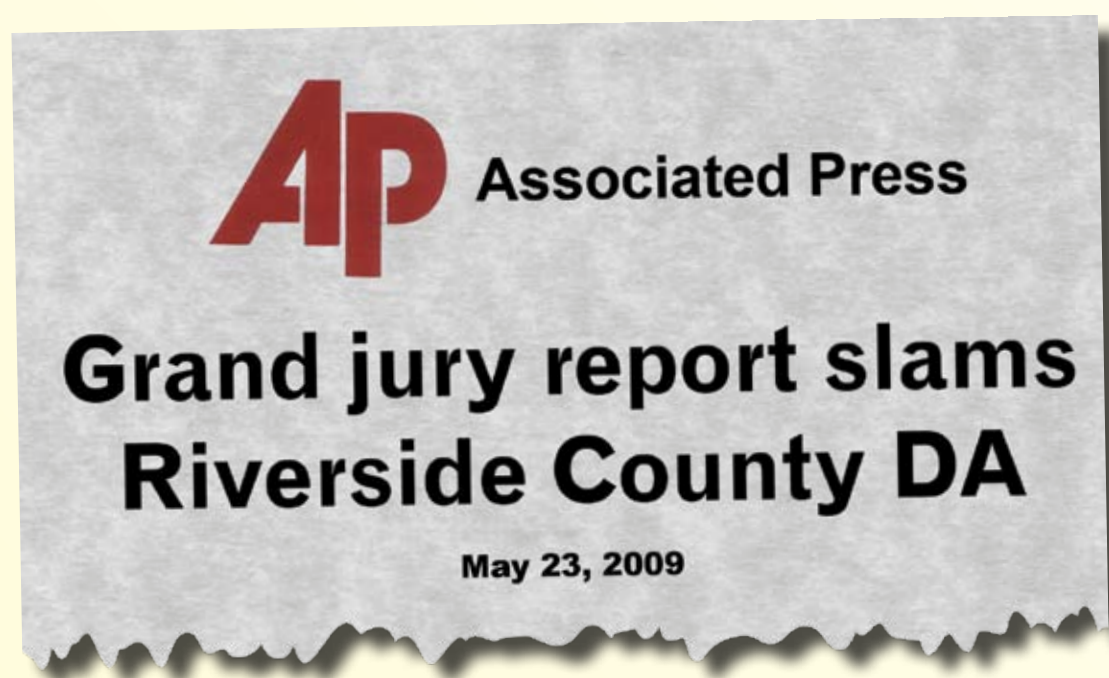

- ▶ Permitted accused Felons to walk free with "not guilty" verdicts.
- ▶ Allowed Riverside's conviction rate to drop to 41.3 % - one of the worst records in the state.
